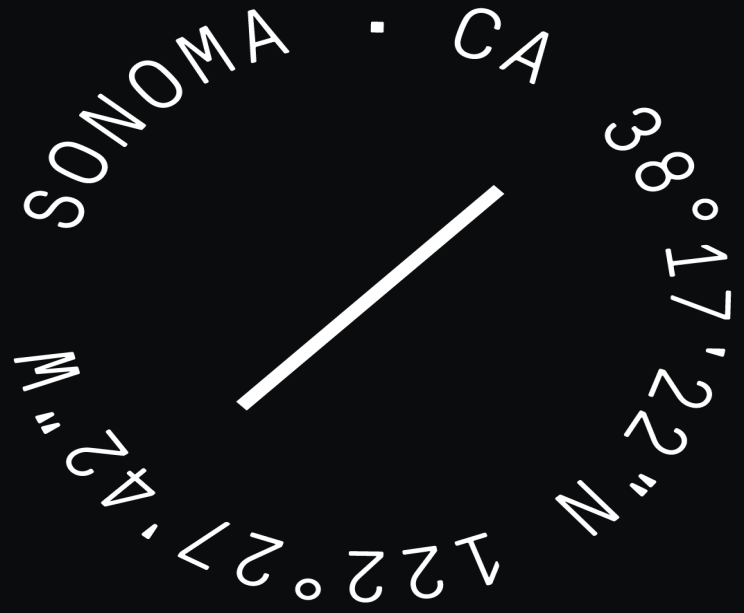

This award-winning triple AVA vineyard estate on 24+/- gated and fenced acres features 11.3 acres of premium vineyard. Through the automated estate gates, you wind past the pond and up the olive tree-lined driveway. Just over the knoll you approach the 2,460 sqft country farmhouse perfectly positioned in a private setting with 360-degree views of the estate's vines.

Wines from the vineyard have consistently been rated 90 to 96 points. The 3 bedrooms, 3.5 bath farmhouse has soaring ceilings, a rustic kitchen, hardwood floors, spacious rooms, and a wrap-around porch with vineyard views from every window of the residence. Detached from the main residence is a remodeled 1 bedroom, 1 bath, 1333+/- sqft guest house with panoramic vineyard views from every window in the home, and from the living room balcony. Below the guest house is a 3-car stall garage of a similar size.

The estate backs up to North Sonoma Mountain Road Regional National Park and Open Land Preserve which is adjacent to Jack London State Park. Ride your horses through the trails directly from your 3-stall horse barn. The location of the ranch is perfectly nestled 6 miles from Glen Ellen and 9 miles from Santa Rosa.

The property has an on-site well for irrigation and domestic that was drilled in 2009 and was tested at 220+/- gallons per minute, limited only by the size of the pump. The turn-key vineyard estate is also part of the Williamson Act for reduced property tax benefits.

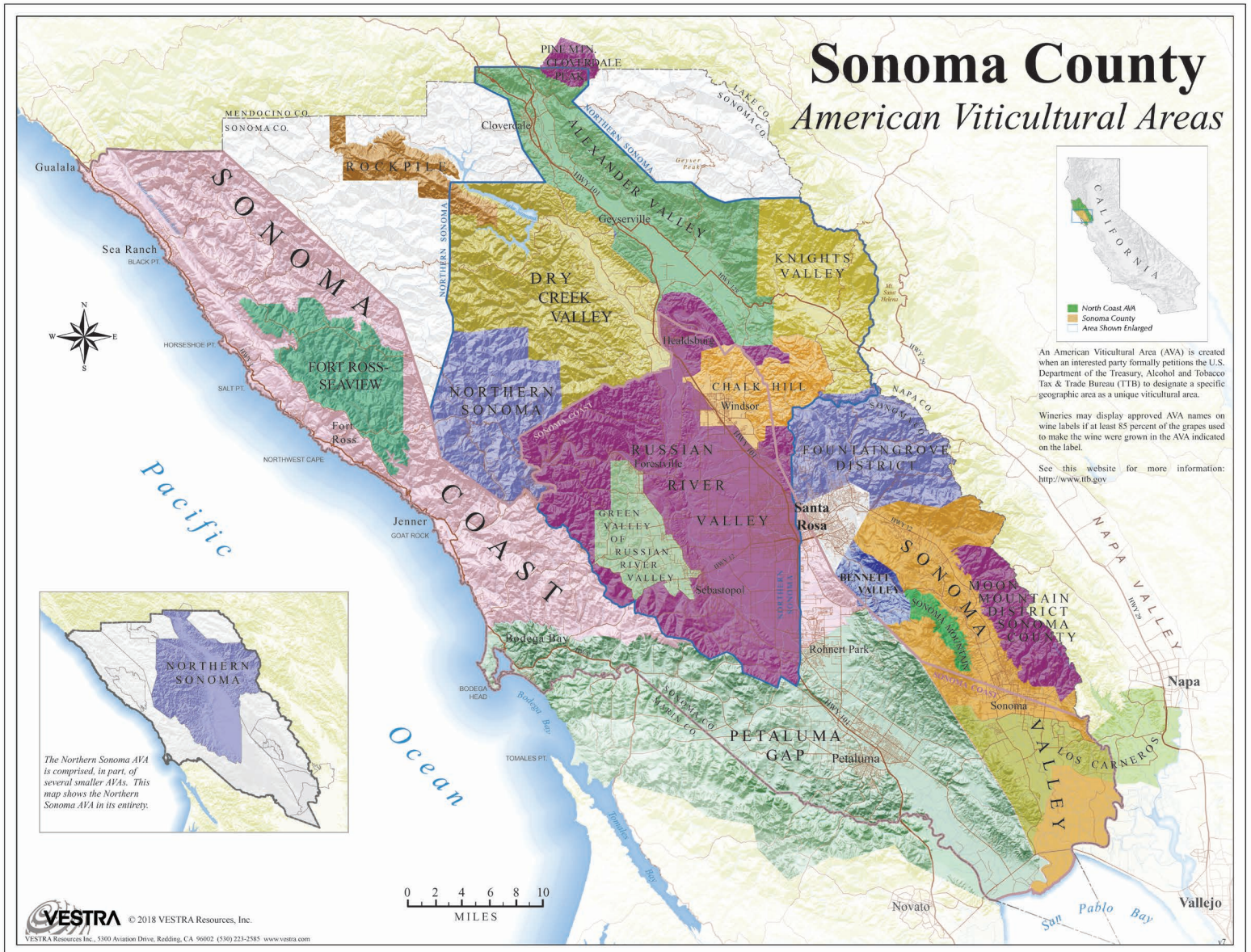
